Assumption of Risk/Release of Liability

I understand that Virginia Regional Ballet Academy will not be held responsible for any bodily injuries sustained while on the premises or for loss or damage to any personal items brought on the premises by students or their families. Each student/parent is responsible for notifying Virginia Regional Ballet Academy of any condition that may affect or limit the dancer during classes.

Registration Fees

An annual registration fee of \$30 for the first dancer and \$15 for each additional dancer is applied per family.

Monthly Tuition

Monthly tuition is calculated on the total number of class hours per week per family. The special Unlimited and Family Unlimited plan rates apply when taking 7 hours or more per week. Payment is due the first week of each month. First month's tuition is due at the time of registration. Per class rate applies to visiting students.

Payment Policies

Registration and tuition fees are non-refundable. Refunds will only be given when Virginia Regional Ballet Academy cancels a class for the rest of the year. Payments received after the 15th of each month will be charged a \$10.00 late fee unless prior arrangements have been made with the office. Cash, check, VISA, and MC are acceptable forms of payment. Virginia Regional Ballet Academy has the right to remove any student from class and/or student performance if account payment arrangements are not kept.

Class Changes

All class changes must be submitted in writing to the office by the 1st of each month. The family is responsible for tuition until written notice of withdrawal from the class/academy is received.

Medical Emergencies

In the event of an emergency, I hereby give authority to Virginia Regional Ballet Academy to obtain necessary emergency medical treatment for myself/my child, with the understanding that the family will be notified as soon as possible.

Photo Release

I grant permission for myself/my child to be photographed for the purpose of promoting and publicizing Virginia Regional Ballet Academy.

Dress Code

All students must furnish their own attire and shoes for classes and shoes and tights for performances, unless otherwise specified by VRBA. Students are required to have appropriate attire by the second week of classes. No dangling earrings, watches, necklaces, or bracelets are to be worn in class. No fingernail polish or long nails. Absolutely NO STREET CLOTHES are to be worn during class. This includes loose fitting t-shirts, shorts, etc. The teacher has the right to dismiss any student from class who does not adhere to the dress code. See handbook for class specific dress code.
